## ***POLICY FOR REPORTING AND DISCLOSURE OF CRIME STATISTICS***

The Assistant School Director prepares this report annually to comply with the Jeanne Clery Disclosure of Campus Security Policy and Crime Statistics Act. The full text of this report can be obtained by requesting a copy from the Assistant School Director or the Registrar. This report is prepared in cooperation with the local law enforcement agencies surrounding our campus and the public road in front of the campus.

Campus crime, arrest and referral statistics include those reported to the Medina County Sheriff's Department, the Ohio Highway Patrol, the School Director, Assistant School Director, and/or the Director of Education. These statistics may also include crimes that have occurred off the campus premises but in Sharon Township where Hamrick School is located.

Each year students, faculty members and staff members are notified by announcements posted in various locations at Hamrick School that the annual crime report is available and may be obtained from the Assistant School Director or the Registrar.

## ***DEFINITIONS OF CRIMES AS USED IN THIS REPORT***

As used in this report, crimes are defined as follows:

1. ***Murder and Non-Negligent Manslaughter*** are the willful (i.e. non-negligent) killing of one human being by another.
2. ***Negligent Manslaughter*** is the killing of another person through gross negligence.
3. ***Sex Offenses*** are any sexual acts directed against another person, without the consent of the victim, including instances where the victim is incapable of giving consent. Sex offenses include rape, fondling, incest, and statutory rape.

***Rape*** is the penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim. This definition includes any gender of victim or perpetrator.

***Fondling*** is the touching of the private body parts of another person for the purpose of sexual gratification, without the consent of the victim, including instances where the victim is incapable of giving consent because of his or her age, or because of his or her temporary or permanent mental incapacity.

***Incest*** is sexual relations between persons who are related to each other within the degrees wherein marriage is prohibited by law.

***Statutory rape*** is sexual intercourse with a person who is under the statutory age of consent.

4. **Robbery** is the taking or attempting to take anything of value from the care, custody, or control of a person by force or threat of force or violence and/or by putting the victim in fear.
5. **Aggravated assault** is an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm. It is not necessary that injury result from an aggravated assault when a gun, knife or other weapon is used which could or probably would result in a serious potential injury if the crime were successfully completed.
6. **Burglary** is the unlawful entry of a structure to commit a felony or a theft. For reporting purposes, this definition includes:
  - Unlawful entry with intent to commit a larceny or a felony;
  - Breaking and entering with intent to commit a larceny;
  - Housebreaking;
  - Safecracking; and
  - All attempts to commit any of the aforementioned.
7. **Motor vehicle theft** is the theft or attempted theft of a motor vehicle.
8. **Arson** is any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property, etc.
9. **Liquor law violations** are defined as the violation of any state law or ordinance prohibiting the manufacture, sale, purchase, transportation, possession, furnishing or use of alcoholic beverages. Drunkenness and driving under the influence are NOT included in this definition.
10. **Drug law violations** are defined as the violation of laws prohibiting the production, distribution, and/or use of certain controlled substances and the equipment or devices used in their preparation and/or use. Also included are the unlawful cultivation, manufacture, distribution, sale, purchase use,

possession, transportation or importation of any controlled drug or narcotic substance.

11. ***Weapons violations*** are defined as the violation of laws or ordinances prohibiting the manufacture, sale, purchase, transportation, possession, concealment or use of firearms, cutting instruments, explosives, incendiary devices or other deadly weapons.
12. ***Hate crimes*** are crimes committed against a person or property which are motivated, in whole or in part, by the offender's bias. Bias is a preformed negative opinion or attitude toward a person or group of persons based on their actual or perceived race, gender, gender identity, religion, sexual orientation, ethnicity, national origin, or disability.
13. ***Dating violence*** is violence committed by a person who is or has been in a social relationship of a romantic or intimate nature with the victim. The existence of such a relationship shall be based on the reporting party's statement and with consideration of the length of the relationship, the type of relationship, and the frequency of interaction between the persons involved in the relationship.
14. ***Domestic violence*** is a felony or misdemeanor crime of violence committed:
  - By a current or former spouse of intimate partner of the victim;
  - By a person with whom the victim shares a child in common;
  - By a person who is cohabiting with, or has cohabited with, the victim as a spouse or intimate partner;
  - By a person similarly situated to a spouse of the victim under the domestic violence laws of the jurisdiction in which the crime of violence occurred, or
  - By any other person against an adult or youth victim who is protected from that person's acts under the domestic or family violence laws of the jurisdiction in which the crime of violence occurred.

15. ***Larceny/Theft*** is the unlawful taking, carrying, leading or riding away of property from the possession or constructive possession of another, or any attempt to do so.
16. ***Simple Assault*** is an unlawful physical attack by one person upon another where neither the offender displays a weapon, nor the victim suffers obvious severe or aggravated bodily injury involving apparent broken bones, loss of teeth, possible internal injury, severe laceration, or loss of consciousness.
17. ***Intimidation*** is unlawfully placing another person in reasonable fear of bodily harm through the use of words and/or other conduct, but without displaying a weapon or subjecting the victim to actual physical attack.
18. ***Destruction/Damage/Vandalism*** of Property is the willful or malicious destruction, damage, defacement or other injury to real or personal property without the consent of the owner or the person with custody and control of the property.

## ***ACCESS, SECURITY AWARENESS AND CONFIDENTIAL REPORTING***

During business hours, Hamrick School will be open to students, employees, contractors, guests and invitees. During non-business hours all access to Hamrick School buildings and facilities is by key, if issued, or by admittance by the School Director or his or her designee.

During the first week of school all new students are informed of campus security matters, including the location(s) on campus where security related matters may be posted, the availability of the Annual Safety and Security Report, including the website location of the report, and where to obtain a hard copy.

All students, instructors, and staff members must be aware of their responsibility for their own security and the security of others. Students, faculty and staff are encouraged to report all criminal activity or public safety related incidents to the Medina County Sheriff and/or school administration as soon as possible. Hamrick School does not employ campus security personnel. Hamrick School does not employ professional or pastoral counselors. Hamrick School has no off-campus housing and no officially recognized student organizations with off-campus housing facilities.

All reports of criminal conduct on campus will be investigated. Violations of the law will be referred to the appropriate law enforcement agency and, when appropriate, will be examined as violations of the school's Student Conduct Policy.

If you are the victim of a crime and do not wish to pursue disciplinary or legal action within the school or criminal justice system, you may still file a confidential report for purposes of inclusion in the annual disclosure of crime statistics. These types of reports can be made to the School Director, Assistant School Director, or Training Manager.

### ***TO REPORT A CRIME***

Community members, students, instructors, staff and guests are encouraged to report all crimes and public safety related incidents to the Medina County Sheriff's Department in a prompt and timely manner. Crimes should be reported to the authorities to ensure the continued safety to all individuals at Hamrick School and to allow us to include them in our annual crime statistics report. Hamrick School does not have a procedure for allowing victims or witnesses to report crimes on a voluntary, confidential basis for inclusion in the annual security report.

### ***DISCLOSURE TO VICTIMS OF CRIME***

Hamrick School will, upon written request, disclose to the alleged victim of a crime of violence or a non-forcible sex offense, the results of any disciplinary hearing or other proceeding conducted by the School against the student who is the alleged perpetrator of the crime or offense. If the alleged victim is deceased as a result of the crime or offense, Hamrick School will provide the results of the disciplinary hearing to the victim's next of kin, if so requested

## ***EMERGENCY NOTIFICATIONS AND TIMELY WARNINGS***

Hamrick School strives at all times to provide a safe environment for our students, faculty and staff. Anyone who becomes aware of an emergency or dangerous situation should immediately report it to the Administration, an Assistant Training Manager, or any other faculty member, who will immediately notify the Administration.

In the event a significant emergency or dangerous situation arises on or near the campus, students, faculty and staff likely or possibly to be affected by the emergency or situation, will be notified by announcement in the classroom, over the school paging system, postings at various locations around the campus, on the school website and social media sites, and/or in any other manner available and appropriate given the circumstances and nature of the emergency or situation. The determination of the existence of an emergency or situation requiring notification, as well as the determination of those persons to whom notice will be provided, will be made by School Administration, including the School Director, Assistant School Director, or Vice President, in consultation with appropriate local authorities, agencies or public utilities, if necessary given the nature of the emergency or situation. Should the nature of the emergency or situation require, notification will also be provided over local television (Channels 3, 5, 8, 19, and 43.)

In the event of such an emergency or situation the school will, without delay, and taking into account the safety of the school community and the community at large, determine the content of the notification given and will initiate the notification process, unless issuing a notification will, in the professional judgment of the School Administration, in conjunction with appropriate local authorities, compromise efforts to assist a victim or to contain, respond to or otherwise mitigate the emergency. As part of the notification, all affected persons will be instructed on how to proceed, and if appropriate, will be directed to a safe location.

At least once a year the School will conduct a test of the emergency notification system. The test will consist of a simulated emergency and will test both the effectiveness of the notification procedure and the effectiveness of the procedures in place to respond to the emergency situation, whether those procedures require evacuation, finding shelter or “sheltering in place”, or other response. The test results will be evaluated to determine the effectiveness of the procedures in place, to identify weaknesses or needs, and, if necessary, to improve the process for the future. Results of the test will be posted in the Student Information Bulletin Board outside the main classroom.

In the event of *criminal activity*, either on or off campus, that in the judgment of the School Director, Assistant School Director, Vice President or Director of Education, constitutes an imminent, ongoing or continuing threat, a campus wide “Timely Warning” will be issued. The warning will be issued by an announcement in all classes, over the school’s paging system, and/or by posting a written “Timely Warning” in various places on the campus and, if appropriate, on the Hamrick School website and social media sites. In any warning issued under this policy the names of the victim(s) of the criminal activity will be held strictly confidential.

Depending on the particular circumstances of the situation, especially in all situations that could pose an immediate threat to the campus and individuals, the School Director, Vice President, Assistant School Director or Director of Education will verbally inform all instructors to insure all students are immediately notified of the situation.

## ***POLICIES CONCERNING SEXUAL ASSAULT, DOMESTIC VIOLENCE, DATING VIOLENCE AND STALKING***

Hamrick School educates students about sexual assault, domestic violence, dating violence and stalking by including materials on those subjects in the orientation materials distributed to incoming students at the start of each class. Those materials include the definition of sexual assault, domestic violence, dating violence, stalking and consent in Ohio (consent is defined as the voluntary agreement or acquiescence by a person of age and with requisite mental capacity who is not under duress or coercion and who has knowledge or understanding). The orientation materials also include information on risk reduction, recognition of the signs of abuse and abusive behavior, and prevention options, including the possibility and methods for safe and positive intervention by bystanders. The materials also include a description of Hamrick School's policies and procedures in the event that a sex offense does occur. The materials, and the information concerning the school's response to such incidents, are also available through the Assistant School Director's office.

Hamrick School prohibits sexual assault, domestic violence, dating violence and stalking on the school grounds. If you are the victim of any of these crimes at Hamrick School, your first priority should be to get to a place of safety. You should then obtain any necessary medical treatment. You should also report the incident in a timely manner. Time is a critical factor for evidence collection and preservation, both for purposes of criminal prosecution and to be used should the victim seek a protective order. You should report the incident to the Medina County Sheriff's Office (330) 725-6631, and/or to the Director, Assistant School Director, or Training Manager who will assist the student in reporting the matter to law enforcement, should the student so desire. Reporting the incident to school officials does not obligate the victim to prosecute. Filing a report with the Sheriff's Office, however, will ensure that the victim receives the necessary medical treatment and tests, provide the opportunity for the collection of evidence helpful in later prosecution, and assure the victim has access to free confidential counseling from counselors specifically trained in the area of sexual assault crisis

intervention. Hamrick School does not offer any on-campus counseling, mental health, or other services for victims of sex offenses.

When school officials are notified by a victim that sexual assault, domestic violence, dating violence or stalking contacts has occurred, they will notify the Medina County Sheriff's Department. The victim of any of these offenses may choose for the investigation to be pursued through both the criminal justice system and under the Hamrick School Student Conduct Policy, or only the latter.

Any student who has been the victim of dating violence, domestic violence, sexual assault or stalking may file a written complaint against the perpetrator with the School Director, Assistant School Director, or Training Manager. No particular form of Complaint is necessary. All such Complaints will be investigated promptly. To the extent possible under existing law, the school will take all steps possible to protect the confidentiality of the name of any victim who chooses to pursue investigation by the school.

In the event that, after investigation, school officials determine that there is a reasonable possibility that an act of dating violence, domestic violence, sexual assault or stalking did or might have occurred, a hearing will be held as soon as possible, but in no event later than seven days after the Complaint, before the School Director, Assistant School Director, and Training Manager, provided that none of those individuals have any conflict of interest or bias against either the accuser or the accused. In the event that any of the hearing officials do have a conflict of interest or bias, that official shall recuse themselves and not take part in the hearing or disposition of the matter. In the event that all of the hearing officials have a conflict of interest or bias, then the hearing shall be conducted before three other members of the school administration, appointed by the School Director. Any decision made at any hearing shall be by majority vote.

Both the alleged victim and the accused shall be entitled to equal representation in any hearing, and both the alleged victim and the accused will be simultaneously informed in writing, no later than five days after the conclusion of any such hearing, of the outcome of any such hearing, which shall be final. A student found by a preponderance of the evidence to have violated the School's Student Conduct Policy by reason of committing domestic violence, dating violence, sexual assault or stalking will be expelled.

A student victim has the option of changing their academic situation after an alleged sexual assault, and Hamrick School will make any change requested if such a change is reasonably available to school officials.

## ***SEX OFFENDER REGISTRATION***

Federal law requires sex offenders already required to register in a State to provide notice of each institution of higher education in that State at which the person is employed, carries on a vocation, or is a student. In the State of Ohio, convicted sex offenders must register with the County Sheriff's Office in their county of residence, which in turn is required to provide the school with a list of registered sex offenders who have indicated that they are employed, carrying on a vocation, or enrolled by or at Hamrick School. A list of any such offenders reported to Hamrick School is available from the Assistant School Director.

Federal law also requires institutions of higher education to issue a statement advising the campus community where law enforcement information provided by a State concerning registered sex offenders may be obtained. In the State of Ohio, convicted sex offenders must register with the County Sheriff's office in their county of residence, which maintains a registry for that county. A state-wide registry is also maintained by the Ohio Attorney General's Office.

## *ALCOHOL and DRUG POLICY*

The possession, sale, use or furnishing of alcohol on the premises of Hamrick School is not permitted and will result in dismissal from school or termination of employment. The possession, sale, manufacture or distribution of any illegal drugs is prohibited under Ohio and federal laws. These laws are strictly enforced by local law enforcement officials and violation could result in criminal prosecution. Possession, sale, manufacture or distribution of illegal drugs is prohibited at Hamrick School and will result in dismissal from school or termination from employment.

Under Ohio law the possession or use of alcohol by anyone under the age of 21 in a public place or in a place open to the public is illegal. It is also illegal to sell, furnish or provide alcohol to anyone under the age of 21. Hamrick School enforces the Ohio underage drinking law, and any violation of its provisions will result in dismissal from school or termination of employment, and may be reported to local law enforcement.

Any violation of these laws is a violation of Hamrick School's Student Conduct Policy and of the conditions of employment for faculty and staff. Violation of these laws will result in dismissal from school or termination of employment, and may be reported to local law enforcement.

Hamrick School has a zero-tolerance policy for drug and alcohol abuse. Hamrick School conducts random drug and alcohol screening during the truck driver training programs. Any student failing a random screen, may take a Leave of Absence in order to comply with the Department of Transportation's Return to Service rules. Once the student has submitted documentation of compliance with those Rules and secures a negative drug screen, the student may return to class. If student fails to complete a rehabilitation program as stated above, the student will be terminated. Any Leave of Absence taken under this provision is subject to all rules and requirements of a Leave of Absence in general, including limits as to time, permissible number of days, and return requirements.

Substance abuse poses a threat to all of us in virtually every aspect of our

lives including school and the workplace. It is up to us, individually and collectively, to address the threat. As responsible individuals, each of us is obligated to provide for their own physical, mental, and emotional health. Our school has a vital interest in ensuring safe, healthful, and efficient working conditions and learning environments for our employees and students. For these reasons, we have established as a condition of employment and enrollment into our training programs a drug-free policy.

Students taking controlled medications that are prescribed for a legitimate reason must provide documentation from the prescribing health care provider within five days upon request. Failure to comply will be deemed a positive drug screen and lead to termination of employment or dismissal from the program.

In addition to dismissal of any student found to be under the influence of alcohol or illicit drugs while on the campus of Hamrick School, any unlawful possession, use, or distribution of illicit drugs or alcohol will be reported to the local police department. Legal penalties for the possession or distribution of illicit drugs vary depending upon the type and amount. The resulting fines can range from \$150 to \$20,000 and confiscation of personal possessions, along with incarceration that can range up to life in prison.

We require that every applicant, student, staff, and faculty member be free of alcohol and/or drug dependency.

The faculty of Hamrick School recognizes that chemical use and/or dependency may interfere with education and may threaten personal welfare, as well as that of other students and employees. No students under the influence of alcohol or other drugs will be allowed to attend class, or to remain on the Hamrick School property. Reasonable suspicion of drug or alcohol use in class or lab is subject to blood or urine testing at that time. Reasons to suspect chemical substance abuse include, but are not limited to:

- 1) noticeable change in behavior
- 2) slurred speech
- 3) smell of ethanol in breath

In accordance with United States Department of Transportation regulations, Hamrick School conducts drug and alcohol testing of students prior to enrollment. In addition, random drug testing may be conducted at any time.

Students and instructors to be tested will be randomly selected in accordance with United States Department of Transportation standards. In addition, students and instructors may be tested for alcohol and/or drugs upon “reasonable suspicion” as permitted by Department of Transportation regulations.

***Under Ohio Law:***

- A person must be 21 years old to drink beer, wine, mixed beverages or spirituous liquor.
- It is illegal for a person under 21 years of age to possess any beer wine, mixed beverages or spirituous liquor.
- It is illegal for ANY PERSON to possess an opened container of beer, wine, mixed beverages or spirituous liquor in any public place.
- It is illegal for any person other than the state to manufacture, sell or distribute in any manner a card or identification card issued for the purpose of establishing a person’s age that displays the great seal of Ohio, the words, “Ohio”, “State”, “Official,” “Chauffeur,” “Commercial Driver,” “Driver,” “Operator,” or any other designation that represents the card as the official driver’s license or identification card of Ohio

***Under Federal Law:***

The following are a small sample of the penalties under Federal law for possession of a controlled substance:

- Prison and/or fines: **21 U.S.C. §844(a)**
- Forfeiture of personal and real property: **21 U.S.C. §§ 853(a)(2) and 881(a)(7)**
- Forfeiture of vehicles, boats, aircraft or other conveyances; **21 U.S.C. §881(a)(4)**
- Civil fines of up to \$10,000: **21 U.S.C. §844a**
- Denial of federal benefits, including student loans, Pell grants, and professional and commercial licenses: **21 U.S.C. §862(b)**

NOTE: THESE ARE ONLY **SOME** OF THE FEDERAL PENALTIES. THERE ARE MANY MORE THAT APPLY IN DIFFERENT SITUATIONS. POSSESSION OF CONTROLLED SUBSTANCES ALSO CARRIES PENALTIES UNDER OHIO LAW.

## ***ALCOHOL AND SUBSTANCE ABUSE INFORMATION***

Hamrick School has developed a drug and alcohol abuse counseling and referral program for students, faculty and staff. The program consists of the dissemination of informational materials and referrals to local agencies. The school refers those seeking assistance to several local organizations and agencies which offer alcohol and substance abuse assistance. Many of these referral and rehabilitation programs are available to the general public for free or for a minimal charge. The school will not be responsible for any charges incurred from these programs nor for their effectiveness.

Informational materials are posted on the Student Bulletin Board located outside the main classroom, and drug and alcohol awareness and abuse are taught as a regular part of the curriculum. Informational materials concerning issues involving illegal drug use and alcohol abuse may also be obtained by contacting the School Director.

### ***Health Risks Associated with the Use of Drugs and the Abuse of Alcohol***

- Drinking excessive amounts of alcohol leads to loss of coordination, poor judgment, slowed reflexes, distorted vision, memory lapses, and even blackouts.
- Alcohol can damage every organ in your body. It is absorbed directly into your bloodstream and can increase your risk for life-threatening diseases, including cancer.
- Alcohol depresses your central nervous system, lowers your inhibitions, and impairs your judgment. Drinking can lead to risky behaviors, including having unprotected sex exposing you to HIV/AIDS, other sexually transmitted diseases, and unwanted pregnancy.
- Drinking large amounts of alcohol can lead to coma or even death.
- Illegal use of drugs can slow your thinking, slow your reaction time, cause confusion, impair your balance and coordination, damage your respiratory system, impair learning ability, damage your organs and cause death.
